

As a result of the findings from the inquiry into copyright, music and small business by the House of Representatives Standing Committees' on Legal and Constitutional Affairs, OneMusic Australia has continued the policy implemented by APRA AMCOS that grants a Complimentary Licence to small businesses which fulfill all of the following three specific conditions:

1. the means of performance is by terrestrial or digital broadcast via radio or television set (one device only) or via headphones from an employee's personal device; and
2. the business employs fewer than 20 people;
3. the music is not intended to be heard by customers of the business or by the general public. Neither the radio or television set (nor any speakers) are located in an area that is accessible to customers or the general public.

**If your music use meets the above criteria, please complete the Agreement below. If your use of music falls outside of the complimentary licence criteria, please contact OneMusic Australia to obtain the correct licence for your business or organisation. Please note: OneMusic Australia has the right to verify the accuracy of any claim to a complimentary licence.**
